Feedback Analysis

Annually, the Internal Quality Assurance Cell gathers feedback from stakeholders, including alumni, students, parents and faculty. The institution website serves as a vital platform for collecting, analyzing, and addressing feedback received from various stakeholders, including students, faculty and alumni. The PTA feedbacks are analysed and addressed at the departmental level by the tutors.
